#### **BOD REPORTS**

## **BOD Chair Report**

Given by Al

- Thanks to everyone who did service at the convention
- · Insurance will be renewed soon. Areas should submit for an insurance certificate
- Impossible Dream book issues have been straightened out, Ed has been in contact with the printer, we will be voting on the purchasing of the book on Monday
- We had a former board member contact the printer about the *Impossible Dream* book, but this is an issue we will talk about Monday, because no one who is not a board member should not contact anyone we do business with
- Convention: we have had some good responses from countries and states. It was a great financial success, some of us want to take credit for it, God has more to do with it than anything
- Want to have a members meeting to address concerns from Areas, we need to go and upgrade the policy ad guidelines for the conventions, they don't sync
- Purchased a website for the 2027 convention, can't give a report about the convention because accounts have to be separated, we are taking the brunt of the fees and this needs to be straightened out. Our two payment systems aren't syncing but I spoke to Kat and Eugene about it, we need to re-input everything back into the system.
- Members are asked to speak on issues and the board has no chance to respond, I think
  we need to talk about stuff at a members meeting if it is not going to be brought before
  the board.
- Personal issues about me have been submitted to the Region but it's not right because I
  have no defense, things are misinterpreted at the Region, they should be addressed at the
  board first.

Maureen: Did you submit a written report for us?

No not yet. I have not had time I have been slammed since the convention. Will submit it probably tomorrow.

<u>Frank:</u> You mentioned positive feedback from other countries, did you get any feedback from hotel?

No we have not we need to address some issues we had with them. We had some audiovisual issues, we need to meet with them and we need to have our close-out meeting so we can get our final numbers.

<u>Bob:</u> You said something about accusations made at the BOD meeting, but this should be included in the report. There has never been a detailed explanation or response, if the person with an issue has a voice at the BOD, then it should be addressed at the BOD. I thought the convention was great. You mentioned there was a critique, what are the concerns of the convention committee? Is there going to be a real vehicle in which real feedback can be give for the development of the 2027 convention? You stated there wasn't a vehicle for people to respond to accusations, but the board should have the ability to respond or not to.

If you have an issue with the board, come to the board instead of coming to the RSC with an issue. We can't take up time at the region to address these things. If they aren't getting resolved at the board then they can come to the RSC but we have been circumvented. Some of these things have not been going according to policy.

<u>Bob:</u> I heard the chair of the programming committee would not divulge the names of the speakers and one of the areas had to petition for them. That seems like an egregious act on programming, why wasn't it just put in a report?

Someone brought the issue me, I brought it to the board and we dealt with it.

Frank: What are the tentative dates and times for the members meeting?

I have gotten everyone's emails and we are going to try to get the meeting together. I'll send you an email.

<u>Tom:</u> Thanks for your service, the convention was great. I have a few things to address. 1. You mentioned insurance for the coming year, has the RSO put down the downpayment?

Not yet, we should be doing that soon. There will be a slight increase.

<u>Tom:</u> We will all need to coordinate on this. 2. You mentioned an effort to revise the policy bylaws, guidelines, etc., is the board planning on getting legal representation to assist? There are resources that exist who give pro bono assistance to non-profits. New York State law has not for profit laws wherein certain things have to exist in non-profit policies, so the board does not have free rein to change things. I can direct you to the pro bono resources. 3. Is there a suggestion box for feedback at the convention? For example, I thought the comedy show was great but could have been partitions off in that large room for better ambiance.

That's a good idea, I was thinking the same thing. I think the last time the BOD policy was revised there was a lawyer on the board.

Antoine: Another thing you can do is measure the room you are having events in based off of how many tickets are bought to provide better ambiance in a room.

<u>Joel:</u> The website lists the board meeting at 6 pm, but they meet at 6:30. [inaudible... something about pool membership?]

<u>Stefan:</u> One hiccup in the convention's registration scheme was that many people, including those who were pre-registered, had to wait almost 2 hours to get into the convention. On Saturday I arrived when registration said it would open at 9 (there was a sign), but I was not able to get into the convention until 11 am.

We talked about that. If you are pre-registered you should just be able to go in, there should be two separate lines, one for pre-registrants and one for day-of registrants. The

first day, the cash register wasn't open. We ran into some difficulties but we have learned from the issues and we will be better able to deal with the conditions that cause those problems.

<u>Maureen:</u> The helpline received a lot of calls about waiting on line, and about the transference of registrations that did not go through.

# **Treasury Report & Closing Balance**

- Expenses: \$5601.25
- Closing balance: \$9,254.94, recommends a \$3,000 donation to NAWS.
- Insurance and donations information are on the second page of the repot
- Please make sure PayPal donations are labeled as to where they are coming from
- Noted donations from areas on the reports that I have not yet received
- Insurance fro this year is all paid up through September, we are moving into the next year's insurance, it is expected to go up but not very significantly. Once we get the break down from the RSO on the insurance due, we'll send out the spreadsheet and areas can start planning. You can look at the spreadsheet for today for an approximation and maybe round it up by 5% so you can plan. It is required as 25% down payment and 9 month monthly payment. Some areas pay all at once some pay over the time period allotted

#### **NEW BUSINESS**

<u>Frank:</u> Motion to donate 3000 to news Caleb seconds. No opposition, motion passes by acclimation.

#### SHARING SESSION

<u>Gary:</u> Thank you for your time, and apologizes to RCMs for any confusion about their nominations. People on the board get pissed off, I stood up and said something at the board when something goes against policy. The not for profit will be subject to 12 traditions and concepts in the first by law. I intend to run again for a board position. I have completed my pool membership service, and it is not true that I have not. There is minimum of 3 months of pool membership required, I did it for 6 months, resigned in 2024 due to a disagreement. The board ignores the policy whenever they feel like it. If there Is any confusion about my nomination the board should come forward as they are required to. I feel like my reputation in this fellowship is being tarnished

Roy: does any one have info for South Jamaica? Kat: Yes.

<u>Babette:</u> It is not spiritual to not let members do service. I am concerned because I received several calls from areas that there was negative information being put out there regarding Gary's vote. That conduct is unbecoming of a recovering addict.

<u>Peter H.:</u> I have served this region for 35 years straight and I have mentored many people here. Joel brought up the issue of people using their last names in the NEZF, this is something that an educated person in public information should know about. Last names are a common thing in public information, we know the potential to give up our last names. It is unprofessional to send a letter to someone in a facility and not give our last names or give our credentials.

<u>Jerry:</u> You may not understand the intricacies of PR writing, it is normal to have last names and credentials, but the flyer should not have gone out to the public.

<u>Alphonso</u>: Gary did a fantastic job for artwork at our convention. Group conscience is god conscience, if the group decides on something, that means the group goes with the group conscience. So when a vote goes in and someone is having a reaction that is visible, it is offensive and it is not in the sprit of being a part of the group.

<u>Bob W.:</u> My gut feeling is that I don't get a good feeling from the 6 abstentions, that usually means that there isn't the right information. There is a conflict of information when the chair says they didn't fulfill their nomination and the nominee says they did, that is cause for concern. There is a need for more clarity about why this person might or might not be qualified. The reporting here has not been transparent.

<u>Joel:</u> I know I missed the window for a motion, but I wanted the body to consider an ad hoc for the policy and wanted to make myself available for that if needed.
